PLEDGE OF ALLEGIANCE / INVOCATION:

Mayor Smith led the Pledge of Allegiance. Roy Bright, resident of Big Stone Gap, Virginia, provided the invocation.

AGENDA CHANGES:

Town Manager Laura Roberts informed Resolution #16, 2025 would be added to the agenda as item # XIV.

CONSENT CALENDAR:

Robin Dotson made a motion to approve the consent calendar, which included the minutes of the March 25, 2025 regular Council meeting, minutes of the April 8, 2025 Budget Workshop, the March 2025 Treasurer's Financial, Police, and Water Plant Reports, and the April 2025 Fire Department, Recreation Specialist, Planning Department, and Special Events Reports. Laura Taylor seconded the motion that passed 5-0.

PUBLIC EXPRESSION:

Larry Deel, resident of 743 Middle Of The World Road, Dante, Virginia, addressed Council regarding his arrest on June 14, 2024, by Officer John Baker of the Wise Police Department. He provided an overview of the circumstances surrounding the incident and informed he was seeking compensation for expenses incurred due to the arrest. He requested Council's assistance in determining if he could be reimbursed. Deel was advised he would be contacted by a representative of the Town.

Shannon Showalter, member of Bearcreek Bowmen Archery Club, requested Council's approval for the Rinehart 100 Archery Tournament to be held at the Town of Wise Sports Complex August 14-17, 2025. He highlighted the success of last year's tournament and requested the facility use fee be waived by the Town. DISCUSSION OF WEST MAIN STREET PEDESTRIAN PROJECT:

Town Planner Reagan Walsh informed, per Virginia Department of Transportation requirements, the Town must undergo a right-of-way phase due to easements needed for the West Main Street Pedestrian Project. She noted the phase would result in delays to the project timeline. Walsh added an opportunity for questions in a public setting was also a required component of the right-of-way phase. She informed Engineers Greg Widener and Tim Mullins from Thompson & Litton, Inc. were present to address project-related inquiries. Councilman Dotson requested the beginning date for the project, which was estimated to be between late 2025 and Spring 2026.
