MINUTES

MEMBERS PRESENT:

PLEDGE OF ALLEGIANCE / INVOCATION:

Wise Fire Chief Jack Mullins led the Pledge of Allegiance. Ronald Large, resident of Wise County, Virginia, provided the invocation.

AGENDA CHANGES:

Town Manager Laura Roberts informed a new Agenda had been provided to include the April 2025 Treasurer's Financial Report, as it was omitted in error on the original document.

CONSENT CALENDAR:

Laura Taylor made a motion to approve the consent calendar, which included the minutes of the April 22, 2025 regular Council meeting, the April 2025 Treasurer's Financial, Police, Water Plant, Fire Department, Recreation Specialist, and Wise Rescue Squad Reports, and the May 2025 Special Events Report. Duane Phillips seconded the motion that passed 5-0.

PUBLIC EXPRESSION:

Regina Gibson, on behalf of the Health Wagon, requested approval to place banners on Townowned property in advertisement of the Move Mountains Medical Mission to be held on July 18th and 19th, 2025 at the Health Wagon facilities located on Patriot Drive in Wise, and "Davey's Shuffle", a back to school event to be held on July 31st, 2025 at the Shelcy Mullins, Sr. Fairgrounds in Wise County. In addition, Gibson requested use of the marquee sign located at Big Glades for advertisement of both events. Town Manager Laura Roberts stated the Town's policy restricted the advertisement of events on the marquee to only those held at Big Glades. Following a brief discussion, Laura Taylor made a motion to approve the request for the placement of the banners in the Town of Wise. Robin Dotson seconded the motion which passed 5-0. Due to the existing marquee policy, Council did not authorize the events to be advertised on the sign.

Sabrina Fox, President of Warriors Little League, informed an end-of-season celebration for the league was scheduled to be held at the Wise Municipal Pool in June. She advised the pool would need to be rented on three separate days to accommodate all players and their families. Fox requested that Council consider waiving or reducing the rental fee for the pool to assist the league financially. Mayor Smith noted a donation to Little League had not been made in the current fiscal year, as had been done upon request in previous years. Following a brief discussion, Laura Taylor made a motion for the Town to donate \$600 to Warriors Little League. Duane Phillips seconded the motion. The vote was recorded by roll call:

NOTICE OF INTENT TO ENACT AND PUBLIC HEARING – NEW SCHEDULE OF CHARGES:

Town Manager Laura Roberts provided an overview of the proposed schedule of charges, highlighting planned increases for FY 25-26. She noted the water and sewer fee increases were necessary to cover the Town's costs. Laura Taylor advised the sewer service fee for the upcoming fiscal year would be set at 150% of water charges. She explained this rate had previously been established but was reduced to 125% several years ago to ease the financial impact on customers due to rising water rates. Mayor Smith opened the floor for a public hearing on "A notice setting forth a new schedule of charges for In-Town and Out-of-Town water and sewer rates, residential and commercial garbage collection, and an increase in real estate tax for FY 25-26". There being no one from the public audience wishing to comment, the public hearing was closed.

HOUSING COMMITTEE MEETING REPORT: COMMUNITY REVITALIZATION FUND – PUBLIC HEARING – ORDINANCE #3, 2025:

Councilman Robin Dotson, Chair, summarized the meeting of the Housing Committee held to discuss a draft ordinance establishing the Town of Wise Community Revitalization Fund and associated program guidelines. He advised potential development sites within the Town were also evaluated. Dotson reported the committee recommended the adoption of the draft ordinance. He further noted discussion with full Council and the Town Attorney was recommended regarding potential development sites for consideration in the Preliminary Engineering Report. Town Manager Laura Roberts informed site-related discussions would take place later in the meeting during Closed Session. A public hearing was held on "AN ORDINANCE OF THE TOWN OF **COMMUNITY ESTABLISHING FUNDING FOR** LOCAL **VIRGINIA** REVITALIZATION FOR THE PREVENTION OF NEIGHBORHOOD DETERIORATION AND AUTHORIZING THE PROGRAM GUIDELINES IN ACCORDANCE WITH VIRGINIA CODE SECTION 15.2-958.5". There being no one from the public audience wishing to comment, Mayor Smith closed the public hearing. Laura Taylor moved to adopt Ordinance #3, 2025. AUTHORIZATION TO AWARD SURPLUS PROPERTY BIDS:

Town Manager Laura Roberts provided a list of bids received from the recently advertised surplus sale, requesting authorization to award purchase contracts to the highest bidders. She stated

authorization was also requested to dispose of or donate items for which no bids were received, as deemed appropriate by department heads. Laura Taylor made a motion to authorize the award of surplus property bids and disposal of equipment as requested. Duane Phillips seconded the motion that passed 5-0.

PUBLIC WORKS COMMITTEE MEETING REPORT:

Caynor Smith, Jr., Chair, reported the Public Works Committee met to consider a request from Wise County regarding the elimination of water and sewer facilities fees. He advised the committee recommended the matter be discussed with all members of Council and the Town Attorney present, which would occur during the upcoming Closed Session.

<u>Personnel</u> – Discussion, consideration, or interviews of prospective candidates for employment; assignment, appointment, promotion, performance, demotion, salaries, disciplining, or resignation of specific public officers, appointees, or employees of any public body as permitted by Virginia Code $\S 2.2-3711(A)(1)$.

<u>Real Property</u> – Discussion or consideration of the acquisition of real property for a public purpose, or of the disposition of publicly held real property, where discussion in an open meeting would adversely affect the bargaining position or negotiating strategy of the public body, as permitted by Virginia Code $\S 2.2-3711$ (A)(3).

COUNCIL COMMENT:

Robin Dotson conveyed a positive outlook on Council's direction and the potential for substantial accomplishments moving forward.

Vice-Mayor Laura Taylor stated the Town of Wise was supported by an optimistic Council and dedicated employees, contributing to an overall positive and encouraging atmosphere. She emphasized the strong potential for continued progress. Taylor also commended Wise Rescue Squad for the quality and thoroughness of its monthly reports and acknowledged the dedication and hard work of all first responders.

Duane Phillips expressed his appreciation to Wise Rescue Squad, Wise Fire Department, and Wise Police Department, acknowledging the dedication and extensive hours contributed by first responders in service to the community.

Teresa Adkins thanked Council on behalf of the Town and Country Garden Club of Wise for Proclamation #9, 2025, in observance of National Garden Week. She expressed appreciation to Public Works staff for their efforts in maintaining the flowers planted throughout the Town.

Mayor Smith commended Wise Rescue Squad for the professionalism reflected in their monthly report. He added improving employee morale had been a goal of the current Council and expressed his belief that this objective had been successfully achieved.

STAFF COMMENT:

Fire Chief Jack Mullins informed Wise Fire Department had obtained a 2005 Pierce Dash Fire Truck from the Fredericksburg City Fire Department.

Town Manager Laura Roberts provided an overview of the Town's upcoming events.

Police Chief Kevin Yates commended Wise Rescue Squad, noting that he consistently requests their presence during high-risk situations due to his confidence in their capabilities.
