Town Manager Laura Roberts advised there were no changes to the agenda.

CONSENT CALENDAR:

Robin Dotson made a motion to approve the consent calendar, which included the minutes of the June 24, 2025 regular Council meeting, the June 2025 Police and Water Plant Reports, and the July 2025 Fire Department, Special Events, and Rescue Squad Reports. ADMINISTRATIVE COMMITTEE MEETING REPORT - RESOLUTION #20, 2025:

Mayor Smith, Chair, summarized the meeting of the Administrative Committee held to discuss changes to the employee policy manual regarding standard hours of operation and holiday pay. He reported the committee recommended the following changes to the Town of Wise personnel policy manual:

- 1. Standard hours for work at the Administrative Office are from 7:45 a.m. to 6:15 p.m., Monday through Friday, with a 30-minute lunch break. Office doors are to be opened for the daily transaction of business from 8:00 a.m. until 6:00 p.m.
- 2. The Town of Wise will follow the State Holiday Schedule. Council approved Town of Wise employees would be paid for all designated state holidays. Fulltime employees shall be paid their regular eight or ten hours of pay for all designated holidays, based on their regular work schedule. Non-exempt employees who are scheduled to work a holiday shall be paid for hours worked at a rate of time and one-half in addition to their regular holiday pay.

Hall noted the co-sponsorship would include use of the Town's parking lot, portable restrooms, and picnic tables, as well as a speaker, if available. The Recreation Committee recommended the Town co-sponsor the Food Truck Rodeo as requested and a \$50.00 fee per food truck be charged each week for use of the parking lot in lieu of meals tax. It was further recommended that food truck operators not dispose of boxes, grease, wastewater, or food on the premises. Robin Dotson made a motion to approve the Committee's recommendation.
