PUBLIC EXPRESSION:

There being no one from the public audience wishing to comment, Mayor Adkins closed public expression.

DRAFT BUDGET DISCUSSION:

Town Manager Laura Roberts summarized the first draft of the proposed budget for fiscal year 2023-2024. She advised that the draft included the majority of the capital expenditures that were presented by Department Heads at the March 15, 2023 meeting. Roberts reviewed proposed rate increases for the General Fund that included all zoning permitting fees. She noted that the proposal also included water and sewer utility rate increases. She reported that the budget included a 3% cost-of-living adjustment and a 3% step raise for eligible employees as adopted by Council in fiscal year 2022.

CLOSED SESSION:

On a motion made by Robin Dotson and a second by Ben Conway the Wise Town Council moved to convene into closed meeting for the purpose of and including:

<u>Legal Matters</u> – Consultation with legal counsel employed or retained by a public body regarding specific legal matters requiring the provision of legal advice by such counsel as permitted by Virginia Code $\S 2.2-3711(A)(8)$.
