

ORDINANCE NO. 12, 2013

**AN ORDINANCE OF THE TOWN COUNCIL OF THE TOWN OF WISE,
VIRGINIA INCREASING GARBAGE COLLECTION FEES IN THE
TOWN OF WISE**

WHEREAS, pursuant to Virginia Code §15.2-928(A) the Town of Wise has previously adopted rates for the collection and disposal of solid waste in the Town of Wise; and,

WHEREAS, the Wise Town Council desires to amend same; and,

WHEREAS, legal notice, advertisement, and public hearing have been provided as required by Virginia Code §15.2, et. seq.

NOW, THEREFORE BE IT ORDAINED AND ENACTED by the Town Council of the Town of Wise, Virginia, that monthly rates for garbage collection and disposal services shall be increased as follows effective July 1, 2013:
